By clicking "Buy Now," "Purchase," "Join Today," or any other phrase on the purchase button, entering your credit card information, or otherwise enrolling, electronically, verbally, or otherwise, you ("Client") agree to be provided with products, programs, or services by Janelle Wehsack ("Coach"), acting on behalf of DISTANT FRANCOPHILE ENTERPRISES PTY LTD, ACN 651 745 014 ("Company"), and you are entering into a legally binding agreement with the Company, subject to the following terms and conditions.

2. Fees and Payment:

Change of mind

Termination by Participant
